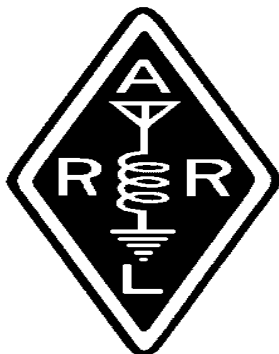

## **We Have a Michigan PRB-1 Bill! HB #5556**

House Bill # 5556, the “Michigan Zoning Enabling Act,” was recently forwarded to House Committee. If passed, this Bill will help codify the aspects of PRB-1 into Michigan zoning laws.

The Bill also includes a “height clause” (i.e. if we stay below the specified height, local governments are not allowed to challenge us except in unusual circumstances, etc.). For more information and a link to the Bill, please take a moment to review the attached MI PRB-1 Project Status Report.

There is a snag, with a Senate version of the Bill. We may need your help getting this Bill sponsored in the Senate.

Now is the time to contact your Representatives to ask them to Co-Sponsor the Bill. Their contact information and a sample Contact Letter template can be found at <http://www.prb1michigan.org/index.htm>.

## **PRB-1 Project Status Report November 2, 2009**

There are several reasons that you received this PRB-1 Project Status Report.

- 1 You were on the Project’s Mailing List which was developed by registering on the <http://www.prb1michigan.org> website. If you do not want to be on the mailing list please send an email to [N8AGS@arri.net](mailto:N8AGS@arri.net).
  - 2 There has been significant progress toward codifying PRB-1 in Michigan. Most of the progress has going on behind the scenes, but we feel that it is time to update you.
  - 3 In order for the project to continue, we need to raise some new funding. Until now, the cost has been donated by a few key Team Members and a few clubs that have offered monetary support. To continue to communicate with the critical stakeholders requires additional funds and we need to communicate with several groups through-out the process, including numerous government officials. Travel to meetings with legislative contacts will also be required, which again costs money. If we are going to continue this effort in Michigan, and we all agree that this needs to be done, we need to acquire some additional funding.

- 4 The time has come to begin a Letter Writing Campaign in support of our legislation, and we need to locate some key volunteers to organize the effort. We have the Bill initiated in the Michigan House, and are working on sponsorship in the Senate. Our legislative representatives need to hear from the Amateur community. They need to hear you asking them to Co-Sponsor House Bill #5556, "The Michigan Zoning Enabling Act." If coordinating this kind of effort is your strong suit, we need you.
- 5 We need the Amateur clubs and other Amateur Organizations to develop club resolutions in support of the Michigan Zoning Enabling Act and send them to us. Tangible evidence of the Amateur Radio community's concern in this matter will carry weight in Lansing and help get this legislation enacted.

So, as you can see there is a lot of activity, but a great deal of work still lies before us.

## **What Can You Personally Do To Help?**

## **PRB-1 Project Status Report November 2, 2009 (continued)**

### **House Bill – Status**

The House version of our Bill is being sponsored by Representative Steve Lindberg. Raoul Rivard, W8RDR initiated his sponsorship and continues to be our single Point of Contact to Rep. Lindberg. Rep. Lindberg is a Ham, N8UZP. This connection made acquiring his sponsorship relatively easy. However, the politics of the State Budget has delayed this process beyond expectations. Consequently, our Bill had been in an apparent holding pattern for a while.

The House version (HB #5556) has been drafted by the Legislative Services Bureau and is currently in the Committee for Inter-Governmental and Regional Affairs. Rep. Lindberg is currently seeking Co-Sponsors. A copy of the Draft Bill can be found at

### **Senate Bill – Status**

We have not been able to get a firm commitment of support from a Michigan Senator. Unfortunately, there is no Senator that is a Ham. We are seeking support from several potential Sponsors, but thus far the response has been somewhat cold. It could be that Michigan's budget issues are also precluding this body of government from considering our Bill. However, we continue to press our contacts.

If you have a solid connection with your Senator, we ask you to consider working directly with us to contact that Senator and solicit the Senator's support for our Bill. If you would like to tackle this approach, please contact me for some sample letters and other supporting documents.

### **Funding**

To date we have received \$425 from the following Clubs; Adrian ARC, Branch County ARC, Hiawatha ARA, L'Anse Creuse ARC and Monroe County RCA. The Team Thanks you for these contributions to our efforts!

## How Did The Bill Become A Zoning Act?

Representative Lindberg felt that our Bill was in fact a Zoning Act versus a Communications Act. His idea is to modify an existing law to incorporate the wording of the Michigan Zoning Enablement Act. We discussed this within the Team and with Rep Lindberg and after all the discussion, it was determined that we would support Rep. Lindberg's strategy.
